If you test positive to any of the NMA banned substances you forgo your placing, all awards and status and are banned from all NMA contests. Results are confidential. Any retests are done at the competitor's expense. Competitor cost is \$45 for test.

Urine Collection Procedures: All competitors will be asked to provide a urine sample and be subjected to thorough urinalysis testing for illegal and/or medically prescribed performance enhancing drugs, *see link for a list of banned substances at <http://naturalmuscle.com/banned.html>*. Collection and processing fee of \$45 is to be paid at time of the sample collection. If a contestant has tested positive for any of the listed substances, he/she will be disqualified from the competition, forfeit any prizes, status and/or rewards, and be unable to compete in any future NMA events. All results are final. By competing in this contest you agree to the results from the urine testing company. Also, if a contestant refuses to submit to drug testing or attempts to manipulate and/or alter a urinalysis sample, then he/she will be immediately disqualified from the competition. Results are confidential; only failures will be notified. Drug test fee is good for 90 days so competitors may submit samples at additional NMA shows but only pay one \$45 processing fee in a 90 day time period. All NMA members may be subjected to off contest post testing.
